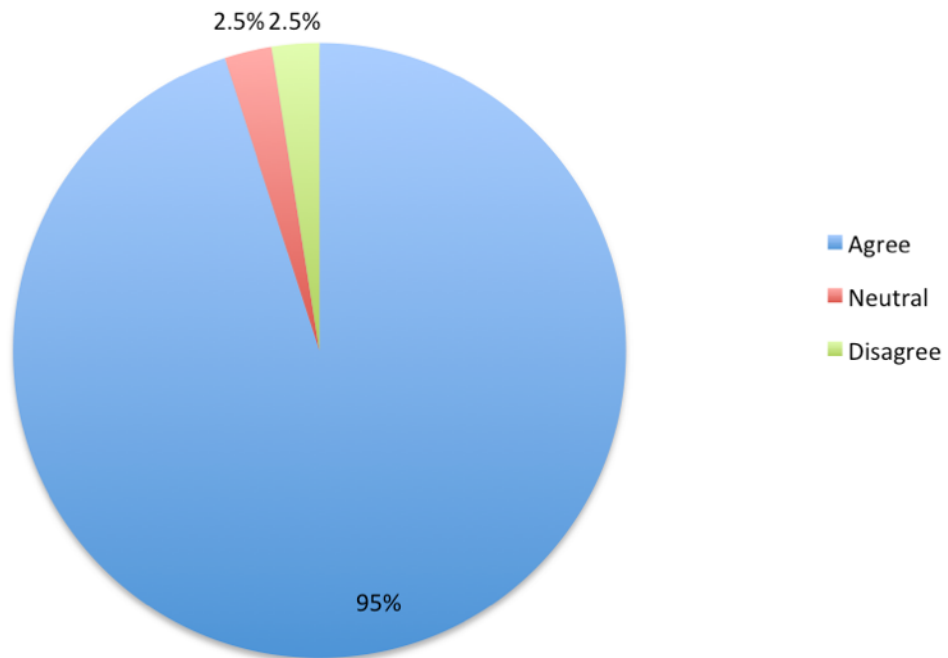

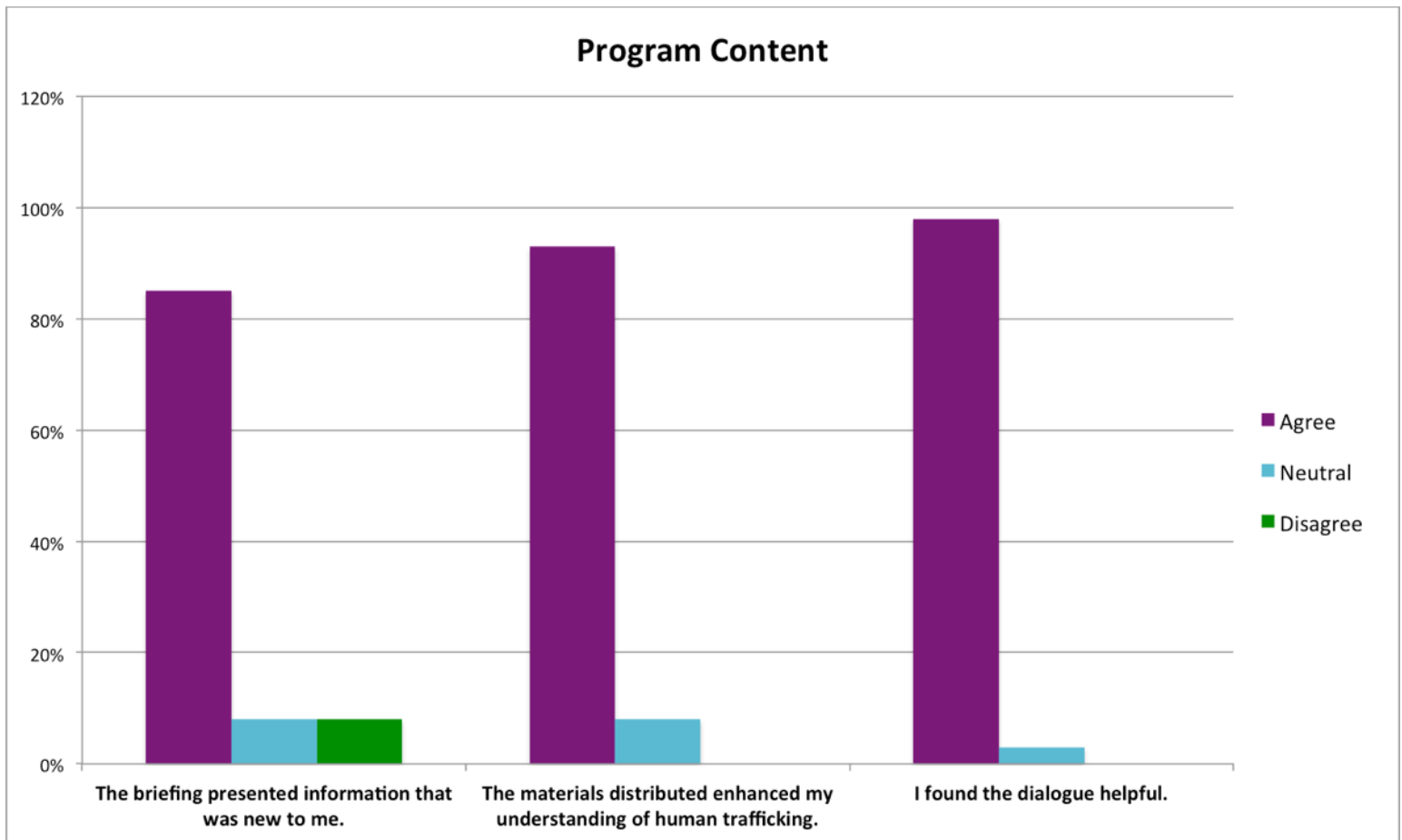

Coalition Building and Impact

*One general manager used the information he learned at the meeting to **report a tip to NHTRC for human trafficking**. He and his team pleaded with the young women to call law enforcement and gave her the NHTRC number to call or text for help.*

*Potter County Sheriff's Office distributed TAT materials to Potter Highway Patrol, reaching **20-30 patrol sergeants**.*

*Lubbock County Sheriff's Office **trained 21 officers**, including the narcotics division and patrol, with TAT materials.*

*A representative from a major **trucking insurance firm** has begun to spearhead a number of efforts within the trucking industry, including presenting TAT's program to carriers at safety director meetings urging them to train their drivers, encouraging corporate dealerships to get*

involved with TAT and showing TAT's training DVD to trucking executives in his network.

Four store managers of major truck stops and travel plazas took TAT materials to put at their places of business and are now receiving TAT's monthly newsletter in order to keep the issue of human trafficking in front of their employees.
